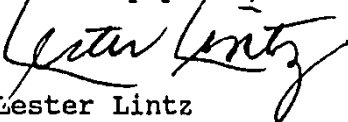

Article I - Name

The name of this corporation is JOHNSON TRANSPORTATION, INC.

Article II - Duration

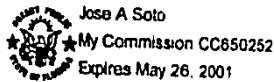
