ARTICLE SIX - LEGAL ACTIONS


No legal actions are pending against the **CUSTOM TECH, INC..**

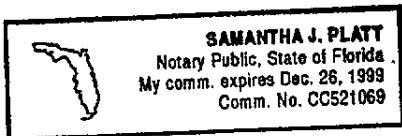
