The name of the Corporation is IDM, INC.

This Corporation shall exist perpetually, unless sooner dissolved according to Law.

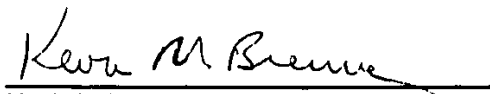
