The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: CONCISE ENTERPRISES, INC.

ARTICLE VII. SPECIAL PROVISIONS

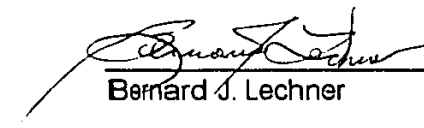

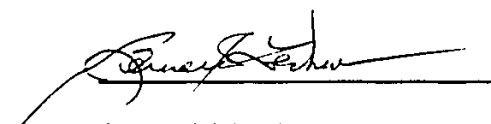
