ARTICLES OF INCORPORATION
OF

The undersigned subscribers to these Articles of Incorporation, RAYMOND A. ROBERTS, KENNETH V. SEEGER, CHARLOTTE A. ROBERTS AND SHANNON E. SEEGER, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is: RAKEN ENTERPRISES, INC.

ARTICLE II

POWERS AND PURPOSES - This corporation is organized for the purposes of transacting any business lawful under the laws of the State of Florida.

ARTICLE III

CAPITALIZATION - The maximum number of shares that this corporation is authorized to have outstanding at any time is Four Hundred Shares (400) of common stock, having a par value of (\$10) per share.
