ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I - NAME

The name of the corporation is DRAWING CONCLUSIONS, INC.

### ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

## ARTICLE III - NATURE OF BUSINESS

This corporation is organized for the purpose of graphic arts production, marketing and sales of greeting cards and any other activity or business permitted under the laws of the United States and the State of Florida.

### ARTICLE IV - AUTHORIZED SHARES

The aggregate number of shares that the corporation shall have the authority to issue is 7,500 shares of capital stock for the par value of \$1.00 per share. The sum of \$7,500.00, the par value of all shares of capital stock of the corporation that have been issued, shall be the stated capital of the corporation at any particular time. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation. The initial Board of Directors shall consist of three (3) members who need not be a resident of the State of Florida or a shareholder of the corporation.

#### ARTICLE X - CUMULATIVE VOTING




