

ARTICLE I - NAME

The name of this corporation is COMPLETE MAINTENANCE SERVICES, INC.

ARTICLE II - DURATION

This corporation shall commence on the date of filing of these Articles with the Secretary of State and shall have a perpetual existence.

ARTICLE III - PURPOSE

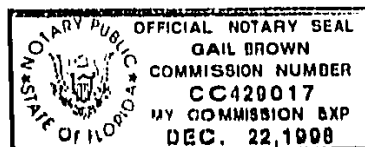
