#### ARTICLES OF INCORPORATION

OF



#### BRIGANTE ENTERPRISES CORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the Laws of the State of Florida:

#### ARTICLE I - Name

The name of the corporation is: BRIGANTE ENTERPRISES CORPORATION
