ARTICLES OF INCORPORATION

I, the undersigned, as proper persons acting as incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

FIRST

The name of the corporation is: Tyler Accounting Service, Inc.

SECOND

The period of its duration is from the date of filing of the Articles of Incorporation and shall have perpetual existence.

THIRD

The purpose of the corporation is: Public Accounting Services.

FOURTH

The aggregate number of authorized shares is: One Thousand

FIFTH

All one thousand shares are issued to Paul D. Tyler evidencing (100%) ownership.

Cumulative voting of shares of stock are authorized.

The total number of shares of capital stock authorized to be issued by the corporation shall be 1,000 shares having a par value of \$1.00 per share. The Board of Directors may authorize shares to be issued for consideration consisting of any tangible or intangible property or benefit to the corporation, including cash promissory notes, services performed, promises to perform services evidenced by written contract, or other securities of the corporation.
