The undersigned, for the purposes of forming a Corporation under Section 607.164 of the Florida General Corporation Act, do hereby certify as follows:

**ARTICLE I
Corporate Name and Address**

The name of the corporation is RHEA F. SEXTON, P.A. and the street address of the Corporation is:

**ARTICLE II
Corporate Purposes**

The Corporation is organized to function as **real estate services** and any related business services and to otherwise engage in any activity or business permitted under the laws of the United States of America and in the state of Florida.
