To Whom It May Concern:

In September of 2001, ownership of Ecoventure Realty changed from Edward R. Oelschlaeger, to Chris E. Oelschlaeger. At the time, we believed we submitted all of the required notices and filings pursuant to this change, but upon speaking via telephone with your representative today, it was discovered that your records do not reflect the change of ownership. Inexplicably, the notice of the requirement to file an annual report was never sent to my attention as the new owner, nor was a delinquent notice ever received. On October 21, 2002, this Notice of Administrative Dissolution was received in our Tampa office. I was out of town last week, and so did not call to inquire about this requirement until today.

In speaking with your representative, we could not determine why the original notices were not received by us (she could not confirm that they were sent, only that they were not returned), but I suspect that it is related to the transfer of ownership.

Currently, Ecoventure Realty is a very small company, with assets totaling only approximately \$2,500. I use the corporation for real estate transactions only once or twice per year. As such, the \$750 reinstatement fee represents an onerous financial burden to both the company and myself. Therefore, we respectfully request that we be granted a waiver of this fee due to a failure to receive notice of the requirement to file an annual report, as well as failure to receive the first late notice.

Enclosed, we have submitted the correct form and a check for \$150. We appreciate your serious consideration of a waiver, but if you should decide to charge the full \$750, please contact me at 813/244-1487 and the balance will be submitted immediately. In addition, it should be stated that this is the first corporation I have ever owned, and now that the annual filing requirements have been articulated and are clearly understood, this situation will not be repeated in the future.
