Pursuant to the provisions of Section 607.187 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is FIELDS INSURANCE, INC.
- 2. The following amendments of the Articles of Incorporation were adopted by all of the Shareholders of the Corporation on September 17, 1997, in the manner prescribed by the Florida General Corporation Act:

The name of the corporation shall henceforth be: FIELDS INSURANCE AGENCY, INC.
