We, the undersigned, EDELIO GARCIA and JOSE L. GONZALEZ, hereby subscribe, acknowledge and file in the office of the Secretary of State of Florida, for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, this Certificate of Incorporation as by law for this purpose provided.

ARTICLE I - NAME

GARBER ENTERPRISES CORP.

ARTICLE II - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is: one hundred shares of common stock, each share to be five dollars par value.

ARTICLE IV - RESTRICTIONS ON THE TRANSFER OF STOCK
