## ARTICLES OF INCORPORATION of THE PC WAREHOUSE, INC.

Pursuant to Chapter 607 of the Florida Business Corporation Act, the undersigned incorporator submiss these Articles of Incorporation for the purpose of forming a for-profit corporation.

#### **Article I**

#### Name And Address

The name of the Corporation is THE PC WAREHOUSE, INC. The principal place of business and mailing address of this corporation is 321 Lambton Lane, Naples, FL 34104.

#### Article II

#### Purpose

The purpose of the corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
