ARTICLE I - NAME

The name of this Corporation is: JOGO, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III - TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is: 21131 Northeast 4th Court, Miami, Florida 33179, and the name of the initial registered agent of this Corporation is JACK SOLOMON . The Board of Directors from time to time may move the registered office of this Corporation to any other address in the State of Florida.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This Corporation shall have four (4) Directors initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one. The name(s) of the Initial Directors of this Corporation are: JACK RUTSKY, JULIUS RUTSKY, MAUREEN RUTSKY, and ROSLYN RUTSKY. The persons named as initial Directors shall hold office for the first year of existence of this Corporation or until his successor is elected or appointed and has qualified, whichever occurs first.

ARTICLE VIII - INCORPORATORS

The name and address of the person signing these Articles of Incorporation as Incorporator is: JULIUS RUTSKY, 2560 Northwest 103rd Avenue, Sunrise, Florida 33322.

ARTICLE IX - INDEMNIFICATION

The Corporation shall indemnify any Officer or Director of any former Officer or Director, to the full extent permitted by law.

ARTICLE X - AMENDMENTS

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.

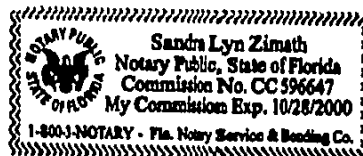


