ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
BERINGER & CLARK, P.A.

Pursuant to the provision of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

9th The undersigned Secretary of **BERINGER & CLARK, P.A.**, hereby certifies that on the 9th day of February, 2000, all of the members of the Board of Directors and the Shareholders of **BERINGER & CLARK, P.A.** (such Shareholders being the only class designated to vote on such amendment and such Shareholders constituting a sufficient number of votes cast for approval of the amendment), by written action in lieu of a joint special meeting in accordance with the provision of Sections 607.0821 and 607.0704, Florida Statutes, approved a resolution amending Article I of the Articles of Incorporation of **BERINGER & CLARK, P.A.**, and that the following is a true and correct copy of said resolution:
