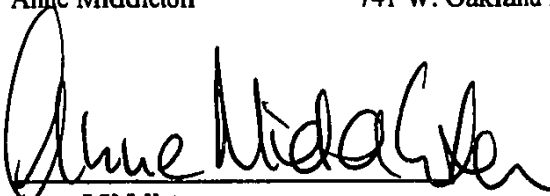
#### ARTICLE EIGHT
