ARTICLES OF INCORPORATION

OF

Brechin Caston, the undersigned, do hereby execute these Articles of Incorporation for the purpose of forming and becoming a corporation for profit under the Florida General Corporation Act, and do hereby certify that I have become such a corporation under and pursuant to the following Articles of Incorporation.

ARTICLE 1 - NAME

The name of this corporation shall be:

ARTICLE 2 - PURPOSE AND DURATION

This corporation is organized for the general purpose of providing services in research and consulting, and to engage in any and all other lawful activity or business permitted under the laws of the State of Florida and of the United States of America.

The corporation shall have perpetual existence.

ARTICLE 3 - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of capital stock with a par value of One (\$1.00) Dollar per share. These shall be designated "Common Shares".
