# ARTICLES OF INCORPORATION OF

#### ARTICLE I NAME

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other State, County, Territory or Nation.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is fifty thousand shares (50,000) of common stock having a par value of \$1.00 per share.

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
