ARTICLE I NAME

The name of the corporation shall be: MBB INC.

ARTICLE II PURPOSE

The corporation may engage in any legal business.

The mailing address of the corporation is 5532 SW 88th Court, Gainesville, Florida 32608.


ARTICLE VII MANAGEMENT
