The undersigned, for the purpose of forming a Corporation for profit under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

Name

Name. The name and address of the Corporation shall be Sknab, Inc., Section 1.1 9440 Phillips Highway, Suite 9, Jacksonville, Fl 32256.

ARTICLE II

Duration

Section 2.1 Duration.
