
ARTICLE XIII - PRE-INCORPORATION AGREEMENT

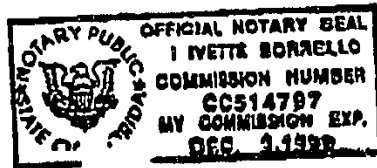
