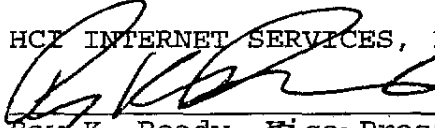

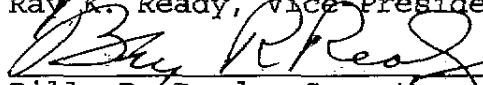
Article I, Section "Name" be and it hereby is amended to read as follows:

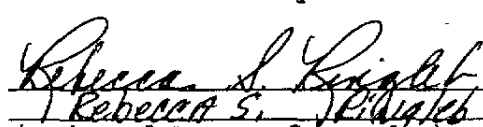
