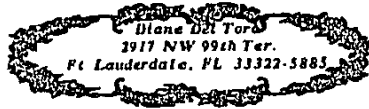

ARTICLE I - NAME

The name of this corporation is JAZZMATAZZ, INC.. The principal address of this corporation is 2917 N.W. 99 COURT, SUNRISE, FLORIDA 33322.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock which shall be designated "Common Shares".

ARTICLE V - PRE-EMPTIVE RIGHTS

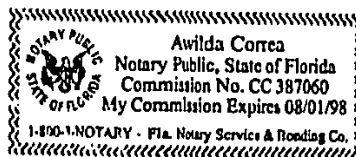
