Article 1  
Name

The name of this corporation is:

Article 2  
Effective Date and Duration

This corporation shall exist perpetually commencing as of September 5, 1997.

Article 3  
Purposes

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

Article 4  
Capital Stock

This corporation shall be authorized to issue ONE HUNDRED THOUSAND (100,000) shares of Common Stock, each having a par value of ONE CENT (\$.01). All the shares of the Common Stock shall have equal rights and privileges and shall be entitled to ratably receive the net assets of the corporation upon dissolution.


**Article 9**


