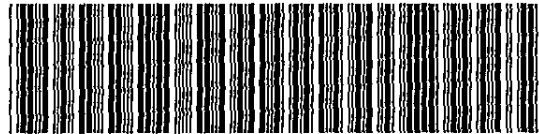

The name of the corporation shall henceforth be Law Offices of Frederick C. Heidgerd, P.A.


SECOND:
