The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, Adopts the following Articles if Incorporation for such Corporation.

ARTICLE 1 - NAME

The name of the Corporation is Double 'D' Freight Lines Inc.

At prices, terms and conditions that shall be fixed by the Board of Directors, such shares of the stock


