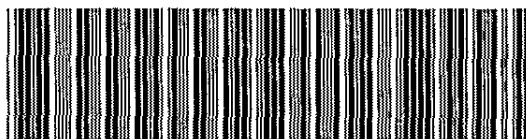

2. Article 1 of the Articles of Incorporation of the corporation is hereby amended to read as follows:
