THE UNDER SIGNED, has executed to following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all right duties and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

To all, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;

To lend money to, a fuse its credit to assist, its officers and employees in accordance with Plorida Latute S607.141;

To purchase, take, receive, subscribe for, or otherwise acquire, ow.., hold, vote, u.e., employ, sell, mortgage, lend, plodge, or otherwise dispose of, and otherwise use and deal in and with, shares or other—terests in, or obligations of, other domestic or foreign corporations, associations, partnerships, c—nviduals, or direct or

indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof;
