Enclosed please find the above corporation's Annual Report for 1997 with a check in the amount of \$150.00 made payable to your department.

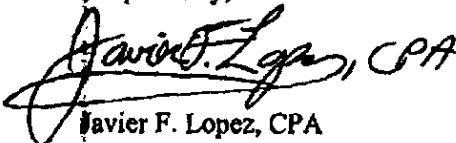
