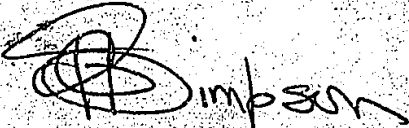

The name of the corporation is Medical Tel-Net, Inc.
