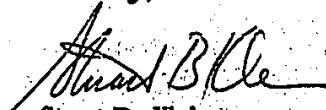

ARTICLE I

The name of the corporation is AIM CAPITAL PARTNERS, INC. The principle office and mailing address is:

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

The corporation shall have perpetual existence.

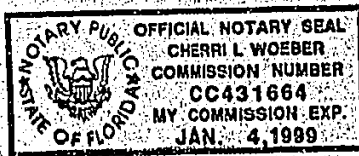

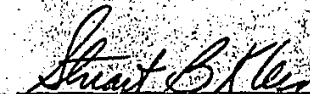

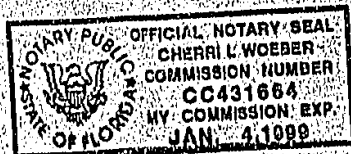
