ARTICLES OF INCORPORATION

INTERNATIONAL TELECOMMUNICATIONS RESOURCES, INC.

ARTICLE I - NAME

The name of this corporation is INTERNATIONAL TELECOMMUNICATIONS RESOURCES, INC. located at 390 Ocean Spray Avenue, Satellite Beach, FL 32937.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

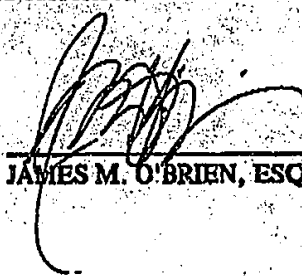
ARTICLE XIV - I.R.C. SECTION 1244 STOCK
