ARTICLE I - NAME

The name of this corporation is **INTERNATIONAL TELECOMMUNICATIONS RESOURCES, INC.** located at 390 Ocean Spray Avenue, Satellite Beach, FL 32937


ARTICLE XIV - I.R.C. SECTION 1244 STOCK
