# ARTICLE I - NAME

The name of this corporation shall be:

AccountAbilities Accounting & Tax Service, Inc.

# ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States or of this State.

# ARTICLE III - CAPITAL STOCK

another corporation or being a director thereof, who is so interested, may be counted in determining the existence of a quorum at any meeting of the Beard of Directors of this corporation which shall authorize such contract or transaction as if he were not such director or officer of such corporation and not so interested.
