This letter requests that the assessment of the late fee be reconsidered, as the original notice was never received.

Integris Services, Inc. was incorporated while I not a resident of Florida. I required that my attorney act as my Registered Agent and use his address for all corporate correspondence. The Second Notice was received by the Registered Agent and forwarded to my attention. When I received the Second Notice, I called my attorney and questioned him about the original notice. He indicated that they had no record of having received any prior notice for the Annual Report: therefore, they had nothing that should have been forwarded to me.
