The undersigned, acting as Incorporator of a corporation under the Florida Business Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I—NAME

The name of this corporation is School Corp., and the principal office is located at 3300 Southwest 34th Avenue, Suite 124B, Ocala, Florida 34474.

ARTICLE II—DURATION

The period of its duration is perpetual.

ARTICLE III—PURPOSE

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV—CAPITAL STOCK

The corporation is authorized to issue 600 shares, all of one class, at \$1.00 par value.

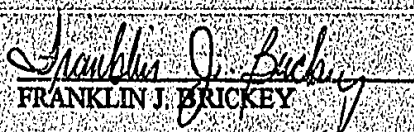

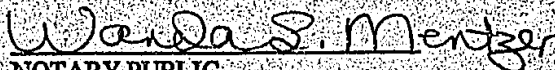

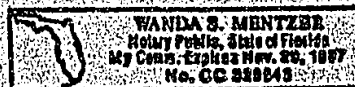
