The Board of Directors and the Shareholders shall have the power to adopt, alter, amend or repeal the by-laws of the Corporation.

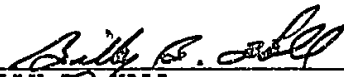
ARTICLE IX

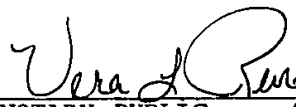

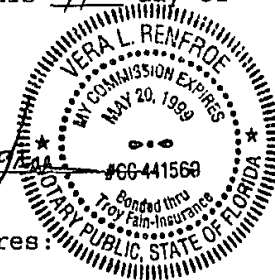
