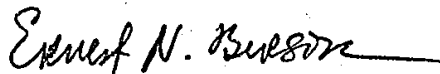

CORPORATE NAME

The name of the corporation shall be:

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

which corporations may be organized under the

The aggregate number of shares which the corporation has authority to issue is 7,500,000

COMMENCEMENT DATE

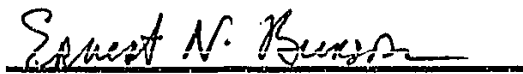
The corporation shall be deemed to commence its existence upon the date the Charter Number is assigned to the corporation by the Secretary of State of the State of Florida.

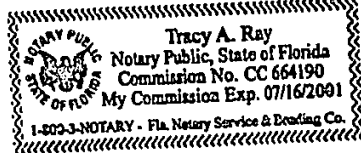
