The **ARTICLES OF INCORPORATION** of **ALWAYS ANSWERING AUGUSTA, INC.**, are as follows:

ARTICLE I.

The name of this corporation shall be **ALWAYS ANSWERING AUGUSTA, INC.**

ARTICLE II.

The duration of this corporation is perpetual.

ARTICLE III.
