ARTICLE I - NAME

The name of this corporation is PAR 3 ENTERPRISES, INC.

ARTICLE II - DURATION

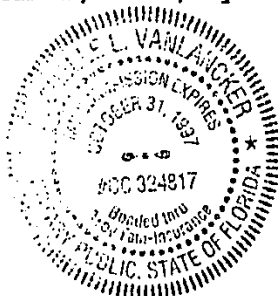
