ARTICLES OF AMENDMENT
OF

1. Article I of the Articles of Incorporation of U.S. Insurance Services, Inc., Florida corporation, is hereby amended in its entirety to read as follows:

ARTICLE I: NAME

EFFECTIVE DATE

The name of this corporation shall be JACK WEST & ASSOCIATES, INC. 1-1-98

2. Pursuant to Sections 607.1005 and 607.1006, the foregoing amendment was adopted by all of the directors of the corporation on the 29 day of OCTOBER, 1997. Shareholder action was not required to adopt the amendment.

3. The foregoing amendment shall become effective on the 1st day of January, 1998, and upon that date, the corporation shall begin to use the name as provided in Article I, as hereby amended.
