Enclosed you will find a copy of the completed annual report for GRADY C. IRVIN, JR., P.A. (1<sup>st</sup> Notice). Today was the first time that either my office or myself discovered this notice.

As set forth on the notice, it was mailed to: Grady C. Irvin, Jr., P.A., **First Union** Tower, 100 Ashley Drive South, Suite 100, Tampa, Florida 33602-5348. Earlier this year I shared office space at this Tampa address as a temporary independent contractor for the law firm of Cunningham Law Group, P.A.; the lessee/tenant in Suite 100. There is a historic pattern of mail addressed to me with "**First Union Tower**" not reaching me directly. My mail has often ended-up in the offices of "**First Union National Bank,**" and eventually sometimes never makes it to me.

Personnel at Cunningham Law Group (now Cunningham, Clark & Greiwe, P.A.) have been forwarding mail to my new address in St. Petersburg, Florida. The incoming mail at Cunningham Law Group usually has a date-stamp affixed when the mail is received. (I have provided you with a few samples). I note that the notice from your division did not bear the usual date stamp. This indicates to me that somehow the mail got mixed-up before it reached me.

Based upon the foregoing, I am uncertain as to whether I must pay the \$550.00 fee, or if I am eligible to pay the \$150.00 fee. In my telephone conversation with the Division earlier today, I was instructed to pay the \$150.00 amount and to provide this letter. I am hereby complying with that request and enclose my check for \$150.00.


