The undersigned subscriber to these Articles of Incorporation, a natural person to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be LOOME INVESTIGATIONS, INC. The principal place of business of this corporation shall be 16057 Tampa Palms Blvd. West, #238, Tampa, Florida 33647.

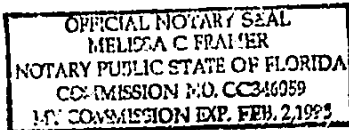

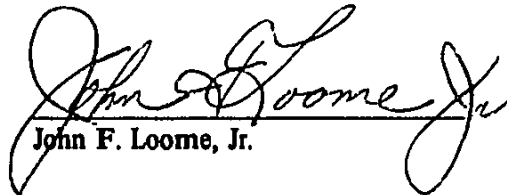
