**ARTICLES OF INCORPORATION  
OF  
INTERNATIONAL PHARMACY CORPORATION**

We, the undersigned, hereby associate ourselves together for the purposes of forming a Corporation For-Profit under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation shall be **International Pharmacy Corporation.**

**ARTICLE II - PLACE OF BUSINESS**

The principal place of business and mailing address of this corporation shall be 633 East Colonial Drive, Orlando, Florida 32803.

**ARTICLE III - TERM OF EXISTENCE**

The term of existence of the corporation shall be perpetual, unless sooner dissolved by law.

**ARTICLE IV - ORGANIZATION**

This is a corporation for-profit, organized under Chapter 607, Florida Statutes.

## **ARTICLE V - CAPITAL STOCK**

The total number of shares of capital stock which the Corporation has the authority to issue is 100,000 (one hundred thousand) shares of Common Stock at \$0.01 (one cent) par value per share ("Common Stock").

## **ARTICLE VI - INDEMNIFICATION**

This corporation shall indemnify any and all present or any and all past officers and directors to the fullest extent permitted by law.

## **ARTICLE VII - CORPORATE PURPOSES, POWERS AND RIGHTS**

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.

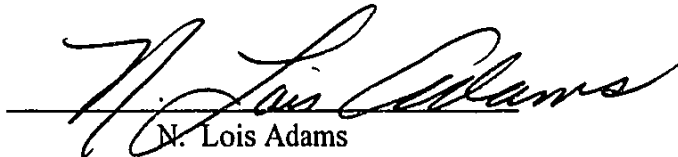
## **ARTICLE X - AMENDMENT**

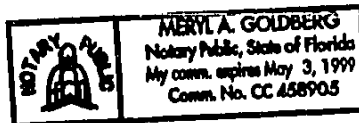

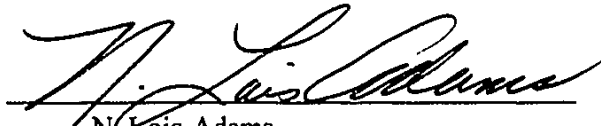
### **REGISTERED AGENT CERTIFICATE**
