ARTICLES OF INCORPORATION

MONTICELLO REALTY INVESTMENTS, INC. TALLAMASSEE, FLORIDA

The undersigned, desiring to form a corporation for profit under the laws of the State of Florida, hereby adopts the following EFFECTIVE DATE Articles of Incorporation:

ARTICLE I: NAME

9-12-57

The name of the corporation is Monticello Realty Investments, Inc.

ARTICLE II: PRINCIPAL OFFICE OR MAILING ADDRESS

The principal office of the corporation is located at, and the mailing address of the corporation is, 1604 Stockton Street, Jacksonville, Florida 32204.

ARTICLE III: CAPITAL STOCK

- (a) Authorized Shares. The total number of shares that may be issued by the corporation is 100,000, all of which shall be of the same class, shall be of the par value of \$.10 per share, and shall be designated common stock.
