ARTICLE ONE NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

- A. Designation. The stock of this corporation shall be known as Common Stock.
- B. Authorized. The maximum number of shares of Common Stock that this corporation may issue is: 100 shares.
  - C. Par Value. Each share of Common Stock shall have no par value.

The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.

### ARTICLE ELEVEN DIRECTOR OUORUM AND VOTING

A majority of the Directors shall constitute a quorum for a meeting of Directors.
