ARTICLES OF INCORPORATION of 20SATLDB, Inc.



The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### **ARTICLE I**

The name of this corporation shall be 20SATLDB, Inc.

#### ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of this state.

#### ARTICLE III

The capital stock of this corporation shall consist of 300 shares of common stock. Each share of common stock shall have a \$1.00 par value and shall be entitled to one vote. Consideration to be paid for each shall be payable in lawful money of the United States or any property, labor or services at just valuation to be fixed by the stockholders. Stock shall be subject to pre-emptive rights.

#### ARTICLE IV

The amount of capital with which this corporation will begin business is \$100,00.
