ARTICLES OF INCORPORATION

OF

SOUTHERN INSULATION & FIREPROOFING, INC.

ARTICLE I - NAME

The name of the corporation is: SOUTHERN INSULATION & FIREPROOFING, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business under the laws of the State of Florida.

ARTICLE III - TERM OF EXISTENCE

The corporation shall have perpetual existence commencing upon the filing of these articles.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares". The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE V- PREFERENCES, LIMITATIONS AND RELATIVE RIGHTS OF SHARES OF CAPITAL STOCK

<u>Section 1, Dividends:</u>

The holders of record of "Common Shares", if any shall be entitled to cash dividends when and as declared by the Board of Directors at the rate per share per annum and at the time and in the manner determined by the Board of Directors.

Section 2, Rights Upon Liquidation or Dissolution:

In the event of any voluntary or involuntary liquidation,

dissolution or winding up of this corporation, after the payment of any and all debts and obligations, the remaining assets of this corporation shall be payable to and distributed ratably among the holders of record of the "Common Shares".

Section 3, Voting Rights:

Except as otherwise provided by law, the entire voting power of the Election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding "Common Shares".

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, class, or series as that which he/she already holds, shall have the right to purchase his/her pro rata share thereof, at the price which it is offered to others.

ARTICLE VII - INITIAL REGISTERED AGENT AND REGISTERED OFFICE

ARTICLE IX - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) Directors initially. The number of Directors may be either increased or diminished from time

to time by the By-Laws but never be less than One (1).
