ARTICLES OF AMENDMENT OF F.F. FASHION VILLAGE, INC.

The undersigned officer of F.F. Fashion Village, Inc., a Florida corporation CARETARY OF STATE "Corporation") delivers these Articles of Amendment in order to amend the Articles of Incorporation of the Corporation filed September 15, 1997 with the Florida Department of State (the "Articles").
